THE GRAND JURY OF THE COUNTY OF NEW YORK, by this indictment, accuses JASON BARNES, a/k/a “J Money”, ALFRED BERNARD, a/k/a “AJ Watts”, ZAKARIA CAMARA, a/k/a “Huncho”, SHASHA DAVIS, a/k/a “Boogz”, RASHAMEL JOHNSON, a/k/a “Jayo”, AYDIN JONES, a/k/a “Dotty”, an adolescent offender, DANDRE MURRAY, a/k/a “Dre Benzo”, JORDAN PACE, a/k/a “Ratty”, RONALD PENDERGAST, a/k/a “Banga”, BOSCHI POPE JR., a/k/a “Bloodie”, [REDACTED] and TYJAE SMITH, a/k/a “Roscoe”, of the crime of **CONSPIRACY IN THE SECOND DEGREE**, in violation of Penal Law §105.15, committed as follows:

The defendants, in the County of New York and elsewhere, during the period from on or about February 16, 2021, to on or about the date of this indictment, with intent that conduct constituting the crime of **MURDER IN THE SECOND DEGREE**, said crime being a class “A” felony, be performed, agreed with each other, and with others, to engage in and cause the performance of such conduct.

OVERT ACTS

In furtherance of said conspiracy and to effect the objects thereof, from on or about February 16, 2021, to on or about the date of this indictment, the following overt acts, among others, were committed in New York County (unless otherwise stated):

1. On February 16, 2021, at about 11:35 PM, ALFRED BERNARD, RONALD PENDERGAST, Co-conspirator # 1, and three other co-conspirators took a bus to rival gang territory in the vicinity of the Drew Hamilton Houses while in possession of a loaded semi-automatic pistol (GUN # 1).
2. On February 17, 2021, at about 12:30 AM, ALFRED BERNARD, RONALD PENDERGAST, Co-conspirator # 1, and three other co-conspirators, in possession of GUN # 1, walked around rival gang territory in the vicinity of the Drew Hamilton Houses for about 20 minutes, looking for rival gang members.
3. On February 17, 2021, at about 1:00 AM, ALFRED BERNARD, RONALD PENDERGAST, Co-conspirator # 1, and three other co-conspirators walked up to the intersection of West 141st Street and 8th Avenue, which is at the corner of the Drew Hamilton Houses, and PENDERGAST fired GUN # 1 at a rival gang member.
4. On February 17, 2021, at about 1:05 AM, as they ran from the vicinity of the Drew Hamilton houses, RONALD PENDERGAST passed GUN # 1 to ALFRED BERNARD.

5. On January 17, 2024, SHASHA DAVIS sent several antagonizing messages over Instagram to a rival gang member.¹ At one point in the conversation, DAVIS sent a message stating, “Any body run into me that’s a opp know wassup ion know what you talking bout rn.”
6. On April 10, 2024, SHASHA DAVIS was in a vehicle in the vicinity of Broadway and West 151 Street while in possession of a loaded semi-automatic pistol (“GUN # 2”), which had a high-capacity magazine, and sixty-eight vials of crack-cocaine.
7. On May 22, 2024, at about 9:30 PM, BOSCHI POPE JR., RASHAMEL JOHNSON, JORDAN PACE, JOEL LUCAS, and several co-conspirators walked to the vicinity of 87 Hamilton Place while in possession of three loaded firearms, looking for rivals in their territory.
8. On May 22, 2024, at about 9:30 PM, BOSCHI POPE JR. pointed at a group of rival gang members down the street, at which point RASHAMEL JOHNSON fired a semi-automatic pistol (“GUN # 3”), JORDAN PACE fired a semi-automatic pistol (“GUN # 4”), and JOEL LUCAS fired a semi-automatic pistol (“GUN # 5”) at the group of rivals.
9. On May 23, 2024, at about 9:25 AM, JOEL LUCAS sent a co-conspirator a screenshot of the Citizen App report of the May 22, 2024, shooting, followed by a text message stating, “Look what we did last night. I trew 4. Eb threw like 5 each”. In response to a text message asking who they were shooting at, JOEL LUCAS replied, “The opps. They was spinning.”

¹ Coded and slang conversations over social media and telephone text messages have been summarized and paraphrased.

10. On May 26, 2024, JORDAN PACE sent several messages to JOEL LUCAS asking LUCAS if he wanted to sell drugs and JOEL LUCAS responded that he did. JOEL LUCAS then sent several messages to JORDAN PACE stating that he spoke to a co-conspirator about an issue they were having with someone over drugs and that the co-conspirator asked for a gun, and that LUCAS didn't give him one.
11. On May 26, 2024, JOEL LUCAS texted JORDAN PACE, "I'm just trynna make sure none of my guys die," to which PACE responded, "Who gun he had?" LUCAS responded "Nun... I told him no. He said fuck it he just gon go up with no g (meaning gun) and try to take they weed bc they took his."
12. On May 31, 2024, JOEL LUCAS texted JORDAN PACE, "Kom os (meaning outside). We need g (referring to a gun) out here all the famous ppl."
13. On June 10, 2024 at about 10:48 PM, in the vicinity 561 West 140 Street, JOEL LUCAS fired GUN # 5 five times at rival gang members in OY territory, shooting himself in the leg one time.
14. On June 10, 2024 at about 10:50 PM, JOEL LUCAS stashed GUN # 5 behind garbage bags in front of 52 Hamilton Place, where it was later recovered by police.
15. On June 18, 2024, at about 11:50 PM, ALFRED BERNARD, RONALD PENDERGAST, TYJAE SMITH, SHASHA DAVIS, DANDRE MURRAY, RASHAMEL JOHNSON, JASON BARNES, and several co-conspirators approached 16-year-old Tresaun Clements and others in the vicinity of Bradhurst Avenue and West 148th Street, yelling out at Clements and the others in substance asking who they were and where they were from.

16. On June 18, 2024, at about 11:50 PM, ALFRED BERNARD, RONALD PENDERGAST, TYJAE SMITH, SHASHA DAVIS, DANDRE MURRAY, RASHAMEL JOHNSON, JASON BARNES, and several co-conspirators surrounded Clements and asked whether Clements was from the Polo Houses, which was rival gang territory.
17. On June 18, 2024, at about 11:50 PM, while surrounding Clements, ALFRED BERNARD, RONALD PENDERGAST, TYJAE SMITH, SHASHA DAVIS, DANDRE MURRAY, RASHAMEL JOHNSON, JASON BARNES, and several co-conspirators demanded Clements' property, repeatedly asking "what you got"?
18. On June 18, 2024, at about 11:50 PM, ALFRED BERNARD punched Clements in the face, causing Clements to fall to the ground and become unresponsive, slipping into a coma and dying several weeks later. Immediately after punching Clements, ALFRED BERNARD took Clements' pink razor scooter.
19. On June 19, 2024, at about 12:00 AM, ALFRED BERNARD, RONALD PENDERGAST, TYJAE SMITH, SHASHA DAVIS, DANDRE MURRAY, RASHAMEL JOHNSON, JASON BARNES, and several co-conspirators walked back through Jackie Robinson Park westbound towards Broadway.
20. On June 19, 2024, at about 1:05 PM, after several video calls with a rival gang member from the same housing development as Clements, DANDRE MURRAY commenced a video call with ALFRED BERNARD.

21. On June 19, 2024, at about 2:07 PM, in a text message group chat, DANDRE MURRAY sent a screenshot of an Instagram Story posted by the rival gang member which had a caption that said, “Get shot if he JACKIN OSAMA OYK DON’T CARE HOW ANYTBOFY FEEL” (referring to committing violence against OY members). In response to the screenshot, SHASHA DAVIS sent a text message to the group stating, “Cs the [n-word] still sleep. [N-words] called me.”
22. On June 19, 2024, at about 2:13 PM, in the same group chat, DANDRE MURRAY texted the group chat that, “I just got otp with them [n-words]” to which RASHAMEL JOHNSON responded by stating, “Fuck it we hrpk they coming up here today.” (meaning they were killers of people associated with the Harlem River Projects, the housing development that Tresaun Clements was from).
23. On June 19, 2024, at about 3:01 PM, in the same group chat, RASHAMEL JOHNSON texted the group stating, “Yoooo broooooo. Yooooooooool. Everybody join the call rn wrd 2 bro.” RASHAMEL JOHNSON then sent the group screenshots from two Instagram stories calling for retaliation against OY for the assault of Tresaun Clements.
24. On June 19, 2024, at about 4:31 PM, DANDRE MURRAY sent ALFRED BERNARD a text message stating, “Yoo they coming to da block tn.” In response to BERNARD asking “Who”, DANDRE MURRAY texted, “Bro didn’t wake up hrp & polo [n-words]” (meaning rival gang members from the Harlem River Projects and the Polo houses).
25. On June 19, 2024, at about 5:43 PM, in the same group chat, Co-Conspirator # 1 texted the group stating, “Yoo woo that [n-word] got brain damage... Word to my mother... It’s over they said... That [n-word] on life support.”

26. On June 20, 2024 at about 8:56 PM, in response to BOSCHI POPE JR. sending a text message asking, “You good”, ALFRED BERNARD texted, “Yea twin ima bet missing for a while.”
27. On June 20, 2024 at about 8:56 PM, ALFRED BERNARD sent a text message to BOSCHI POPE JR. stating, “I’m bout to run this shit up. Mak on bro”, to which POPE JR. responded, “As you sturdy imma run it up for you don’t be texting no one you hurd [n-words] is telling.”
28. On June 27, 2024, AYDIN JONES sent text messages to BOSCHI POPE JR. stating in substance that he’d just run into rival gang members outside and asking POPE JR. to come, to which POPE JR replied, “Im boutta call azh rn imma have mandy walk the g (meaning gun) to you rn folks.... She coming down the block rn. Black hoodie in the bag...”
29. On September 26, 2024, at about 9:45 PM, SHASHA DAVIS and TYJAE SMITH walked to rival gang territory in the vicinity of West 163rd Street and Broadway while in possession of a loaded semi-automatic pistol (“GUN # 6”).
30. On September 26, 2024, at about 9:50 PM, SHASHA DAVIS and TYJAE SMITH approached an occupied 2006 Toyota Sienna van that was parked on West 163rd Street in between Broadway and St. Nicholas Avenue, at which point a person in the van fired a gun at DAVIS and SMITH, who then ran away.
31. On September 26, 2024, at about 9:51 PM, as the 2006 Toyota Sienna van pulled out of the parking spot and drove westbound toward Broadway, DAVIS ran out into the middle the street and fired GUN # 6 three times at the van as it drove away.

32. On October 2, 2024, BOSCHI POPE JR. posted an Instagram Story of a photograph of three firearms – a revolver, semi-automatic pistol, and semi-automatic pistol with extended magazine – laying on a bed with thumbs down emojis superimposed over each firearm.
33. On October 24, 2024, at about 6:02 AM, several hours after the murder of Clarence Jones, a/k/a “CJ”, Co-Conspirator # 8 sent a text message via his Instagram account, stating in part, “I will not shed a tear until blood is shed.” Two hours later, the co-conspirator sent a text message via his Instagram account to another person stating in part, “It’s war...[n-words] took my lil brother meech...This city turning red.”
34. On October 24, 2024, at about 11:01 AM, ALFRED BERNARD posted a photo of Clarence Jones to his Instagram account with a caption that read in part, “U Jusss broke my hearttttt baby boyyyyy...Na WTF CJ.”
35. On October 24, 2024, at approximately 11:29 AM, in a recorded phone call, JASON BARNES informed a co-conspirator about the murder of Clarence Jones.
36. On October 24, 2024, at approximately 4:23 PM, JASON BARNES texted ALFRED BERNARD asking, “wya” and then told BERNARD to, “come to My shit”. ALFRED BERNARD responded by sending a text message to JASON BARNES stating, “We out to drew. Me u an q.” JASON BARNES then responded, “They got shoes for you” (meaning firearms).
37. On October 24, 2024, at approximately 4:35 PM, in response to a text message from ALFRED BERNARD stating, “U don’t wanna bend say that,” JASON BARNES replied, “I always wanna bend my opps w my mans tf.”

38. On October 24, 2024, at approximately 4:36 PM, JASON BARNES sent a text message to ALFRED BERNARD stating in part, “Its tnt thou and drew is gonna be mad hot.” Several seconds later, JASON BARNES sent a text message to ALFRED BERNARD stating, “And its a oy meeting tdy on the block.” ALFRED BERNARD loved both messages.
39. On October 24, 2024, at approximately 4:37 PM, ALFRED BERNARD sent a text message to JASON BARNES stating in part, “drew [n-words] out[side]. An they in the nick.”
40. On October 24, 2024, at approximately 6:46 PM, ALFRED BERNARD posted a video to his Instagram account with a caption that read in part, “LLCJ” (meaning long live CJ).
41. On October 24, 2024 at approximately 9:52 PM, ALFRED BERNARD sent a live location to JASON BARNES and then sent him a text message stating “U downstairs”, to which BARNES replied “Yeah.”
42. On October 24, 2024, at approximately 10:31 PM, ALFRED BERNARD, JASON BARNES, Co-Conspirator # 8, and two co-conspirators traveled to the St. Nicholas Houses in possession of a semi-automatic pistol (“GUN # 7”) and a second semi-automatic pistol (“GUN # 8”).
43. On October 24, 2024, at approximately 10:33 PM, ALFRED BERNARD recorded a video to his cellphone of himself and Co-Conspirator # 8 displaying firearms while BERNARD stated, “Bending for CJ.”
44. On October 24, 2024, at approximately 10:33 PM, ALFRED BERNARD posted the above video to his Instagram account, tagging the St. Nicholas Houses and with the caption reading in part, “LLCJ YK IM COMING FOR U BABY BOYYYYYY.”

45. On October 24, 2024, at approximately 10:35 PM, ALFRED BERNARD reached into the pink backpack worn by JASON BARNES as they walked through the St. Nicholas Houses and took out GUN # 7.
46. On October 24, 2024, at approximately 10:39 PM, ALFRED BERNARD fired GUN # 7 five times at two people walking through the St. Nicholas Houses as Co-Conspirator # 8 chased after them. Co-Conspirator # 8 then fired GUN # 8 five times at the two other persons as he chased them.
47. On October 30, 2024, at approximately 6:02 PM, ALFRED BERNARD, JASON BARNES, RONALD PENDERGAST, TYJAE SMITH, Co-Conspirator # 1, and Co-Conspirator # 3 attended a candlelight vigil for Clarence Jones at 1428 Fifth Avenue.
48. On October 30, 2024, at approximately 7:38 PM, in the courtyard of 1428 Fifth Avenue, ALFRED BERNARD fired two shots from GUN # 7 as Co-Conspirator # 8 stood next to him inside the building.
49. On November 27, 2024, at approximately 6 AM, inside 147-25 94th Avenue, in Queens County, ALFRED BERNARD kept GUN # 7, loaded with live rounds, under a seat cushion in his bedroom.
50. On December 2, 2024, at about 7:10 PM, RASHAMEL JOHNSON sent a text message to AYDIN JONES stating, “We troopin it. U comin.” JONES responded by texting, “no dont troop it today wait tmr i was gone spine tmr that’s what i told dre b” (meaning DANDRE MURRAY).
51. On December 2, 2024, at about 7:11 PM, RASHAMEL JOHNSON sent a text message to AYDIN JONES stating, “Nah wuu we outside. Tn. No wait. We outsideee.”

52. On December 2, 2024, at about 8:50 PM, RASHAMEL JOHNSON, DANDRE MURRAY, and a co-conspirator walked to rival gang territory in the vicinity of the Drew Hamilton Houses in possession of GUN # 6.
53. On December 2, 2024, at about 8:53 PM, RASHAMEL JOHNSON, DANDRE MURRAY, and a co-conspirator walked to the front of a deli across the street from the Drew Hamilton Houses and observed multiple rival gang members inside of the deli.
54. On December 2, 2024 at about 8:53 PM, RASHAMEL JOHNSON took out GUN # 6 and fired it six times into the deli, striking one person inside.
55. On December 3, 2024, DANDRE MURRAY posted an Instagram Story of a video of several people walking down the street at night with hoods over their heads, masks over their faces, and gloves on, and the location tagged as “HRP” (meaning Harlem River Projects, rival gang territory).
56. On December 3, 2024, in response to a message from [REDACTED] stating, “You gone troll all day” with a laughing emoji, RASHAMEL JOHNSON sent a series of text messages stating, “Wrda bro I’m outside again today. Nd again nd again. Not playin no more 100. [REDACTED] replied stating, “An again an again.”
57. On December 8, 2024, DANDRE MURRAY posted an Instagram Story of a photograph of a Waze navigation map showing that the user was near the Harlem River housing development, which was rival gang territory.
58. On December 12, 2024, JOEL LUCAS sent text messages to AYDIN JONES asking JONES in substance to pick up a firearm.

59. On December 15, 2024, BOSCHI POPE JR. posted an Instagram Live video in a story depicting BOSCHI POPE JR., TYJAE SMITH, and Co-Conspirator # 1 together. In the video, POPE JR. held the camera up to his face and stated, “[N-words] know what this means,” followed by the sound of a firearm being racked.
60. On December 17, 2024, in a music video posted to Youtube, JASON BARNES, DANDRE MURRAY, RONALD PENDERGAST, AYDIN JONES, BOSCHI POPE JR., and several co-conspirators expressed disrespect for the death of Tresaun Clements, at one point rapping that, “Nuski (referring to Clements), punched in the face [n-word] done!”
61. On December 21, 2024, DANDRE MURRAY posted an Instagram Story of a photograph of RONALD PENDERGAST, RASHAMEL JOHNSON, AYDIN JONES, DANDRE MURRAY, and BOSCHI POPE JR., standing together with two firearms displayed and pointed at the camera.
62. On December 27, 2024, at about 10:44 PM, AYDIN JONES, RASHAMEL JOHNSON, ZAKARIA CAMARA, JOEL LUCAS, and Co-Conspirator # 4 assembled at RASHAMEL JOHNSON’s apartment in the Bronx while in possession of firearms.
63. On December 27, 2024, at about 10:51 PM, after walking to the elevator bank and waiting for the others, AYDIN JONES texted JOEL LUCAS stating, “Bro we out. Tf u just waiting n the krib for.” JOEL LUCAS responded, “Yu dumb we going with other Niklas gang. Only got 1 g” (meaning gun).

64. On December 27, 2024, at about 10:54 PM, AYDIN JONES texted JOEL LUCAS stating, “bro we out the hunch (meaning ZAKARIA CAMARA) is right there wtf. dicksucker wtmd ya [n-words] blowing ma shit im boutta spin on ya [n-words] procrastination wtmd.” JOEL LUCAS responded, “They said they waiting for the next bus. Leaving in 3 minutes.”
65. On December 27, 2024, at about 11:56 PM, RASHAMEL JOHNSON, AYDIN JONES, ZAKARIA CAMARA, JOEL LUCAS, and Co-Conspirator # 4 walked to rival gang territory in the vicinity of the Harlem River Projects.
66. On December 28, 2024, at about 12:11 AM, RASHAMEL JOHNSON, AYDIN JONES, ZAKARIA CAMARA, JOEL LUCAS, and Co-Conspirator # 4 hid across the street from the Harlem River Projects and waited.
67. On December 28, 2024, at about 12:18 AM, after a person walked out from the Harlem River Projects, RASHAMEL JOHNSON, AYDIN JONES, ZAKARIA CAMARA, JOEL LUCAS, and Co-Conspirator # 4 emerged from their hiding spot across the street.
68. On December 28, 2024, at about 12:20 AM, RASHAMEL JOHNSON and Co-Conspirator # 4 brandished a semi-automatic pistol (“GUN # 9”) and GUN # 6 and fired them at the person across the street. Co-Conspirator # 4 passed GUN # 9 to JOEL LUCAS, who then attempted to shoot it.
69. On December 28, 2024, at about 12:22 AM, RASHAMEL JOHNSON, AYDIN JONES, ZAKARIA CAMARA, JOEL LUCAS, and Co-Conspirator # 4 ran southbound on Adam Clayton Powell Boulevard, where JOHNSON hid GUN # 6 under a parked vehicle.

70. On December 28, 2024, at about 12:39 AM, Co-Conspirator # 4 ordered a Lyft to pick up RASHAMEL JOHNSON, AYDIN JONES, ZAKARIA CAMARA, and Co-Conspirator # 4 and take them home.
71. On December 28, 2024, at about 1:44 AM, AYDIN JONES sent a series of text messages to another person stating, “I just trooped through mad blocks. I ain’t eat all day. I’m mad hot rn.” About one minute later, JONES texted, “I just threw 10 n hrp. we just threw 10 n hrp” (meaning they just shot ten times in rival gang territory in the vicinity of the Harlem River Projects).
72. On January 6, 2025, at about 1:30 AM, BOSCHI POPE JR., RASHAMEL JOHNSON, AYDIN JONES, [REDACTED], RONALD PENDERGAST, DANDRE MURRAY, TYJAE SMITH, and two co-conspirators walked to rival gang territory in the vicinity of the Douglass Houses, while carrying GUN # 6, a semi-automatic pistol (“GUN # 10”), a second semi-automatic pistol (“GUN # 11”), and a third semi-automatic pistol (“GUN # 12”).
73. On January 6, 2025, at about 1:30 AM, BOSCHI POPE JR., RASHAMEL JOHNSON, [REDACTED] AYDIN JONES, and RONALD PENDERGAST brandished GUN # 6, GUN # 10, GUN # 11, and GUN # 12 and then fired them approximately twenty times at two individuals standing outside a deli on West 103rd Street and Amsterdam Avenue.
74. On January 6, 2025, at about 3:56 AM, BOSCHI POPE JR., RASHAMEL JOHNSON, AYDIN JONES, [REDACTED], RONALD PENDERGAST, DANDRE MURRAY, TYJAE SMITH, and three co-conspirators posed for photographs in rival gang territory in the vicinity of the Drew Hamilton Houses. In the photographs, they displayed hand signs representing OY and disrespecting rival gangs.

75. On January 9, 2025 at about 2:41 AM, RASHAMEL JOHNSON posted the above photographs to an Instagram Story and tagged the Drew Hamilton Houses.
76. On January 13, 2025, at about BOSCHI POPE JR. hid a revolver pistol (“GUN # 13”) inside a cereal box in the back of a deli located at 3494 Broadway.
77. On January 28, 2025, at about 9:21 AM, BOSCHI POPE JR., Co-Conspirator # 5, and Co-Conspirator # 6 entered the New York County Criminal Courthouse located at 100 Centre Street.
78. On January 28, 2025, at about 10:21 AM, RONALD PENDERGAST, TYJAE SMITH, and Co-Conspirator # 7 entered the New York County Criminal Courthouse at 100 Centre Street.
79. On January 28, 2025, at about 11:00 AM, BOSCHI POPE JR., RONALD PENDERGAST, TYJAE SMITH, and three co-conspirators exited the courthouse, met up outside, and then walked back into the courthouse and through security armed with two scalpel blades.
80. On January 28, 2025, BOSCHI POPE JR. posted a story on Instagram of a hand holding a scalpel. On the bottom of the photo, the location was tagged as “Criminal Court 100 Centre Street Manhattan.”
81. On January 28, 2025, at about 11:56 AM, RONALD PENDERGAST exchanged five Facetime calls with Co-Conspirator # 3 before walking into Supreme Court Part 93 with RONALD PENDERGAST, TYJAE SMITH, Co-Conspirator # 6, and Co-Conspirator # 7.

82. On January 28, 2025, at about 12:03 PM, while inside Supreme Court Part 93, Co-Conspirator # 3 texted PENDERGAST asking “Yo. Ya seen him?” to which PENDERGAST replied, “AB (referring to the nickname of a rival gang member) in here. We on him.”
83. On January 28, 2025, at about 12:03 PM, RONALD PENDERGAST texted Co-Conspirator # 5, “AB in here. We on to him.”
84. On January 28, 2025, at about 12:05 PM, while inside Supreme Court Part 93, RONALD PENDERGAST texted Co-Conspirator # 3, “We just seen watts” (meaning ALFRED BERNARD). Co-Conspirator # 3 texted PENDERGAST asking, “Ab tyna act like he don’t see ya?”, to which PENDERGAST responded, “Na he see us.”
85. On January 28, 2025, at about 12:08 PM, RONALD PENDERGAST texted Co-Conspirator # 3, “We on to him (referring to the rival gang member). It’s 5 of us 2 of them”, to which Co-Conspirator # 3 responded, “Omgg U wish I was there. Pablo (Co-Conspirator # 5) wit ya?” PENDERGAST responded, “He down stairs”. Co-Conspirator # 3 then texted PENDERGAST, “Ya gon break them down lmaoo. Ik he panicking rn.”
86. On January 28, 2025, at about 12:10 PM, RONALD PENDERGAST, BOSCHI POPE JR., TYJAE SMITH, Co-Conspirator # 6, and Co-Conspirator # 7 walked out of Supreme Court Part 93 and waited for the rival gang members outside the courtroom. While waiting outside, PENDERGAST exchanged four FaceTime calls with Co-Conspirator # 5.

87. On January 28, 2025, at about 12:13 PM, after rival gang members exited Supreme Court Part 93, RONALD PENDERGAST, BOSCHI POPE JR., TYJAE SMITH, Co-Conspirator # 6, and Co-Conspirator # 7 followed them and blocked their path to the elevator bank.
88. On January 28, 2025, at about 12:13 PM, Co-Conspirator # 5 exited an elevator down the hall in the direction of where the rival gang members were walking.
89. On January 28, 2025 at about 12:14 PM, RONALD PENDERGAST, BOSCHI POPE JR., TYJAE SMITH, Co-Conspirator # 5, Co-Conspirator # 6, and Co-Conspirator # 7 surrounded the two rival gang members outside the elevator bank, and then proceeded to assault and slash both rival gang members. Co-Conspirator # 5 discarded one of the scalpels as court officers arrived to intervene.
90. On March 7, 2025, at about 6:00 AM, RASHAMEL JOHNSON kept GUN # 6 and GUN # 11 inside Co-Conspirator # 2's house in Edwardsville, Pennsylvania.
91. On March 29, 2025, SHASHA DAVIS posted an Instagram story of a caption that said, "Ohhh Gawdd This Weather Make Me Wanna Send a [n-word] Up" with a hand and spark emoji (meaning he wanted to kill someone).
92. On March 30, 2025, SHASHA DAVIS exchanged several messages with a rival gang member on Instagram in which DAVIS told the rival gang member that, "Ya still do nun for boy dat got his flight crashed [fist emoji] but stay suckin our yickk". In response, the rival gang member texted DAVIS that he'd been to OY territory more than five times to do shootings since Clements died. DAVIS responded, "Ducking? Never dat [laughing crying emoji x2] atp ya must not love dat [n-word] enough to really come looking for [n-words]."

93. On April 12, 2025, [REDACTED] posted an Instagram Story of a photograph of SHASHA DAVIS and [REDACTED] standing behind the caption “Happy O Day Boogie” and [REDACTED] displaying a hand sign indicating he was a shooter of rival gang members from the River Park Towers.

94. On July 20, 2025, DANDRE MURRAY was in possession of a semi-automatic pistol (“GUN # 14”) hidden inside his backpack.

SECOND COUNT:
