

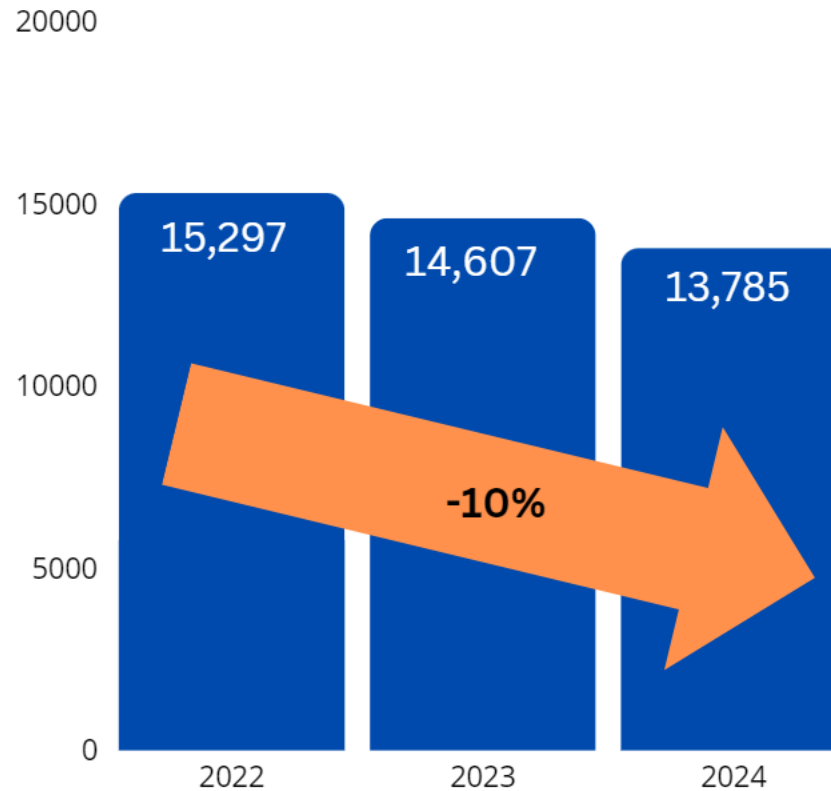

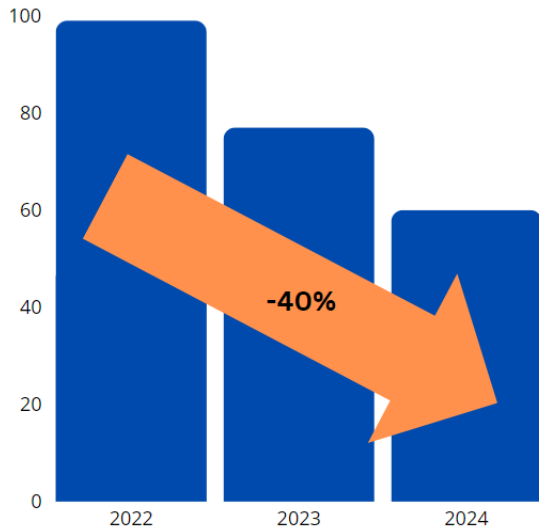
Total Index Crimes in Manhattan 2022 --> 2024



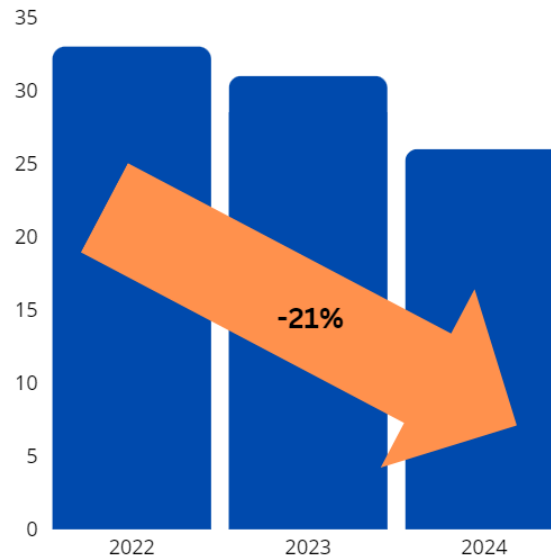

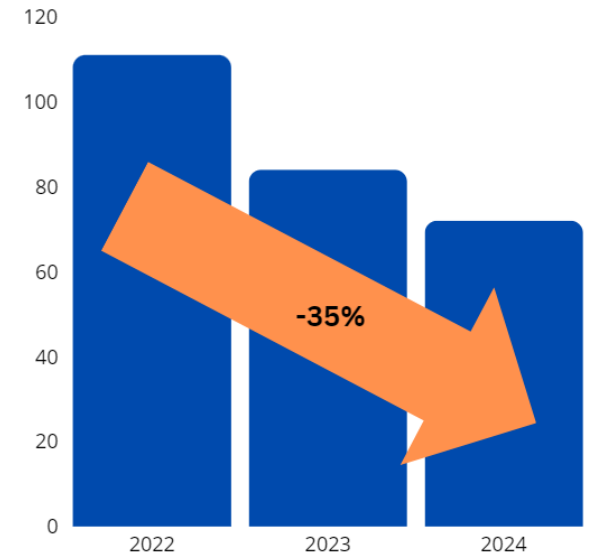

Homicides in Manhattan



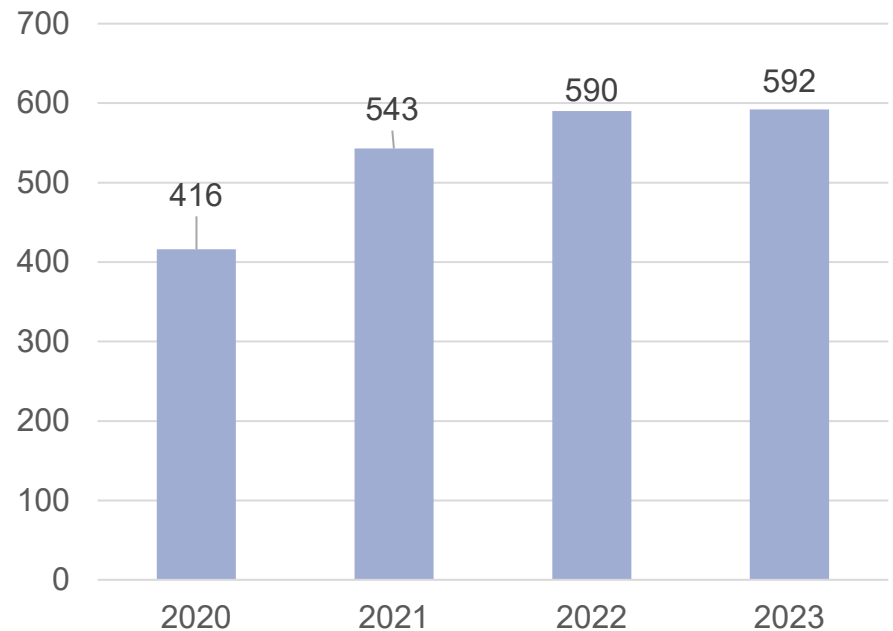

Number of Gun Prosecutions*

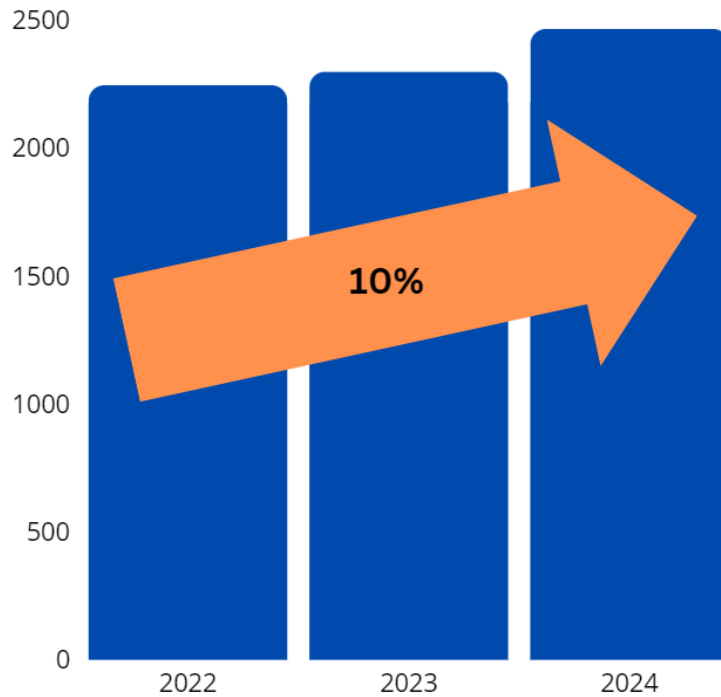

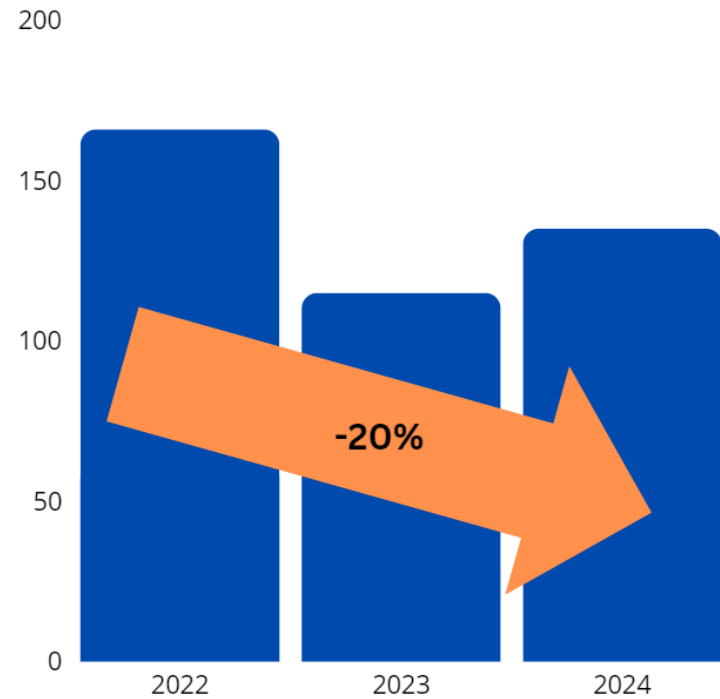

Felony Assaults in Manhattan

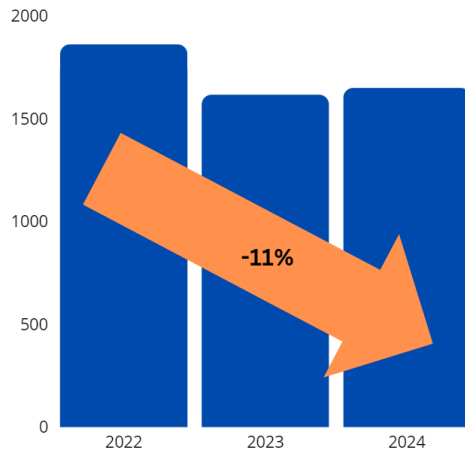

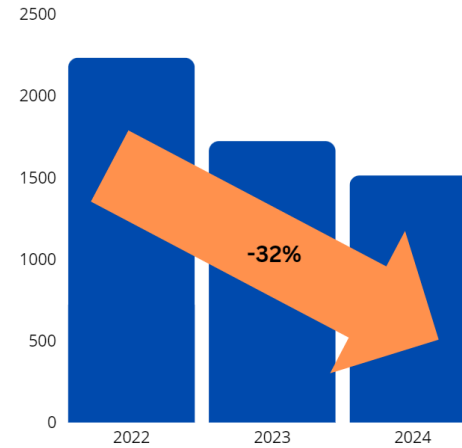

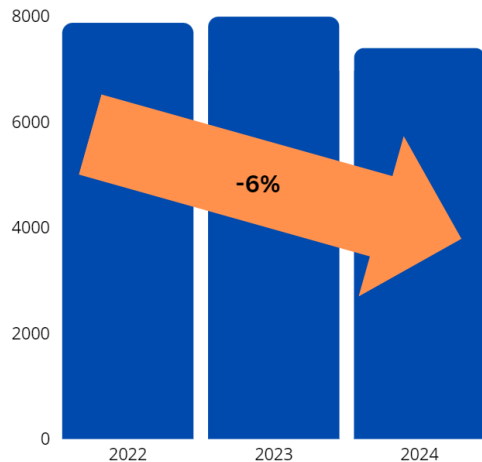
Robberies in Manhattan



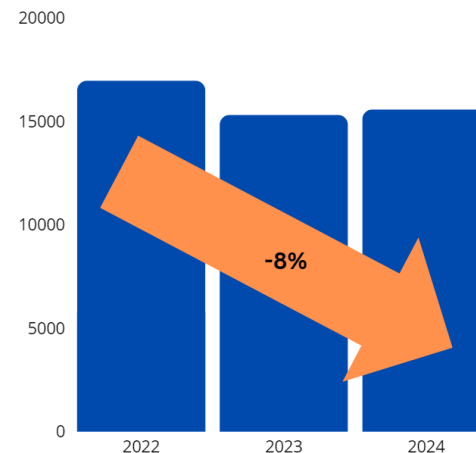
Burglary in Manhattan



Grand Larceny in Manhattan



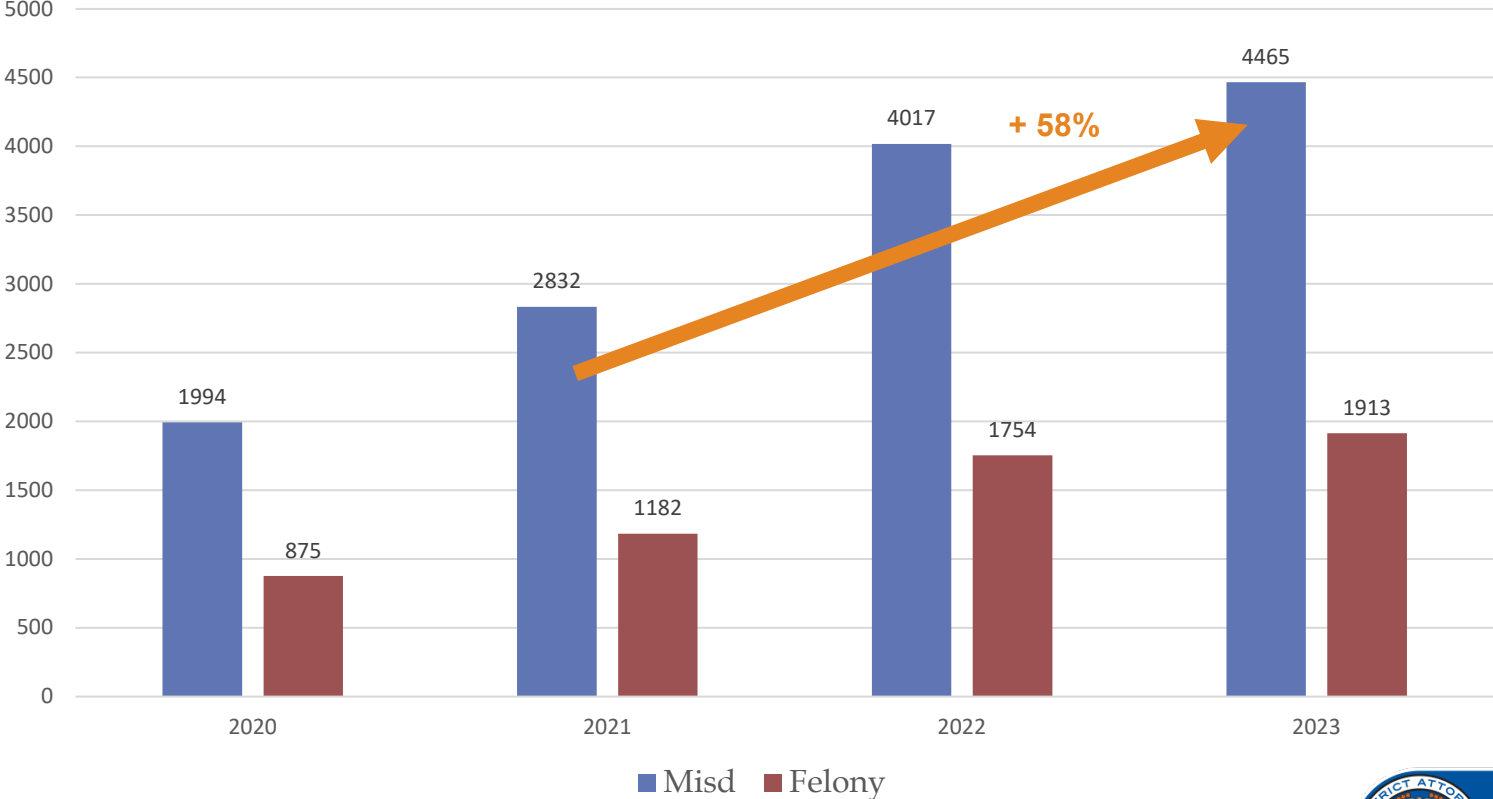
Petit Larceny in Manhattan

RETAIL THEFT

■ Targeted Enforcement of Recidivists

- Since their 2022 or 2023 retail priority arrest alert was added, **178 out of 221 (81%)** priority recidivists were impacted by DANY in at least one of three ways as of 3/7/2024.
 - **97 people (44%)** were indicted on a DANY case
 - **138 people (62%)** received a pathways disposition on a DANY case
 - **77 people (35%)** received a carceral sentence on a DANY case
- This is in addition to our regular prosecutions of shoplifting



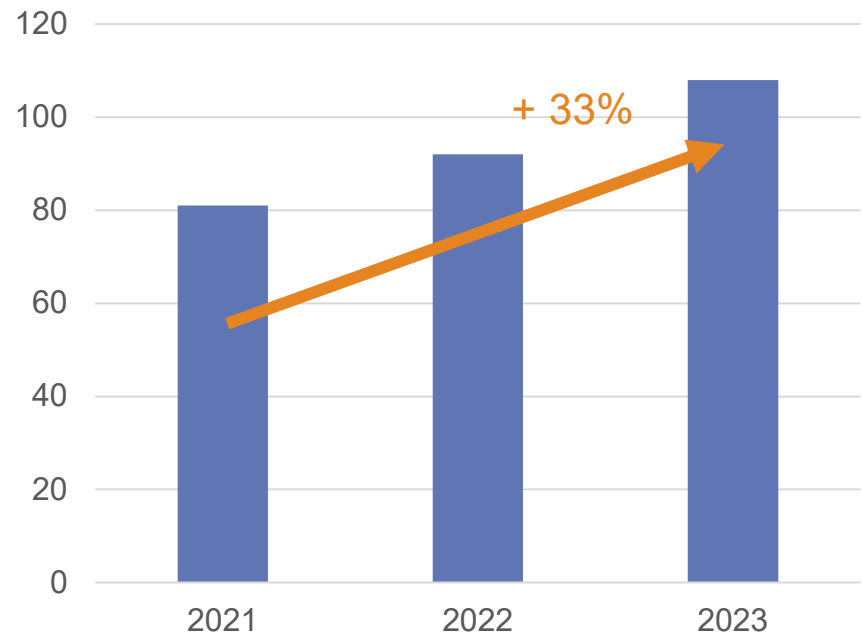

HATE CRIMES

- Thanks to City Council funding, more resources for the Hate Crimes Unit.
- 17 trained cross-designated hate crimes prosecutors. Increased outreach to impacted communities.
- Anti-Asian, anti-Semitic, anti-LGBT, anti-Black, anti-Hispanic, and anti-Muslim are most common offenses.
- Docket has increased since October.

Hate Crime Prosecutions Initiated* in Manhattan

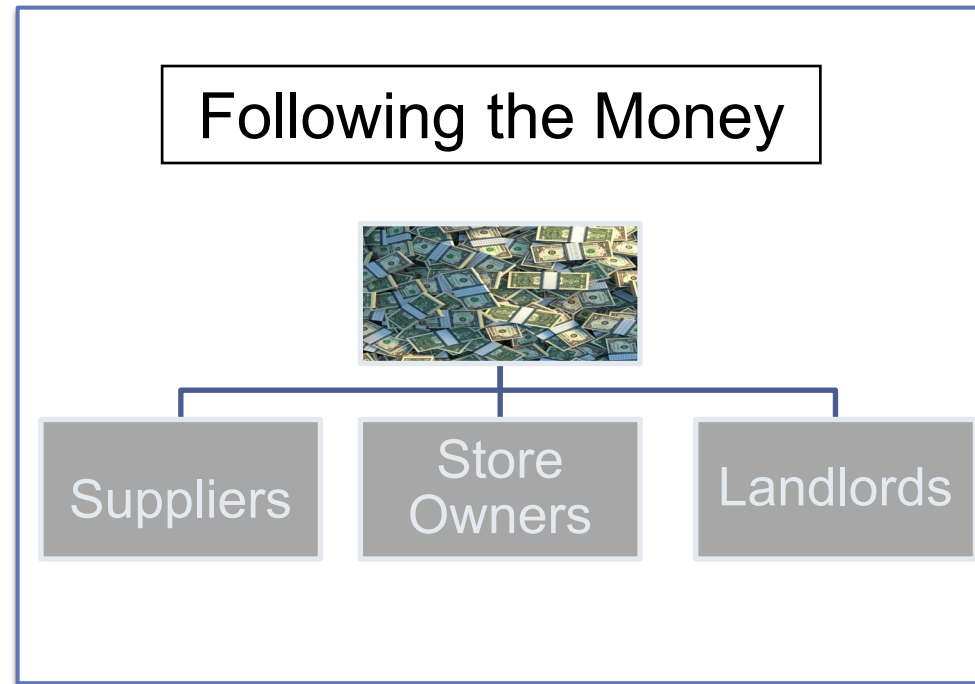

ILLEGAL CANNABIS SHOPS

- 2024 state law changes significant for new city/state enforcement
- Steps taken by DANY before the law change include:
 - Using both civil and criminal authority focused on the players profiting: Smoke shops, suppliers, and landlords
 - Used our RPAPL authority to initiate evictions of 30+ stores – including several LES stores in the past two weeks
 - 2022 Criminal case targeted the owner of 11 stores; continue ongoing investigations into similar conduct.
 - Working with landlords and the real estate industry to enforce commercial leases



ADDRESSING THE MENTAL HEALTH CRISIS IN THE CRIMINAL JUSTICE SYSTEM

- Announced \$9 million investment from DANY
 - Neighborhood Navigators (The Bridge)
 - Court Navigators (Fortune Society)
- Advocating for expansion of mental health court and mental health services

PATHWAYS TO PUBLIC SAFETY

- Launched new Division, hired and co-located Pathways Deputy Chief in each trial bureau
- Every felony case is assessed for problem-solving court within 24 hrs. of criminal court arraignment
- Doubled felony problem-solving court referrals and acceptances

*Graduates refers to people who successfully completed programming in a Manhattan felony problem-solving court in CY 2022 or CY 2023.



SURVIVOR SERVICES

- **\$1.1 million** expansion
- **200%** increase in referrals to survivor services
- **280%** increase in crisis responses
- Automated, mandatory connection on all VFO cases with civilian witnesses



PREVENTION INITIATIVES

- Community anti-gun violence grants
- Harlem & Midtown Interagency Coalitions
- Neighborhood and court-based navigators
- SNL Restorative Healing Circles with NYAGV



SPECIAL VICTIMS

- Created **Intimate Partner & Sexual Violence Bureau** within Special Victims Division with dedicated, specially trained staff
- Launched **SVD Advisory Council** to solicit ongoing feedback from diverse experts
- 2023 marked the 1st class of **dedicated misdemeanor ADAs** in the history of DANY

WORKER/TENANT PROTECTION

- Worker Protection:
 - New unit announced in February
 - More cases, new industries
- Tenant Protection:
 - Indicted developers for allegedly abusing 421-a program
 - Several ongoing investigations related to harassment and other criminal activity
